## UPDATES ON LEGISLATION

Bill 24 (2016) — Relating to Refuse — Bill 24 (2016) states that, "No person shall throw, drop, place, dump, or deposit refuse, to include bulky wastes on a street, roadside, alley, highway, or public place except as provided in this chapter." Any person caught violating illegal refuse activity shall be subjected to a civil fine not exceeding \$250. Bill 24 was reported out of the Committee on Public, Health, Safety and Welfare meeting on March 29, 2016 and is up for passage on second reading and is scheduled for public hearing at the City Council Meeting on April 20, 2016.

Resolution 16-62 — Requesting the City to Work with the State to Establish a Collaborative Funding Process by Which Service Providers and Developers May Apply for Homeless Assistance or Homeless Housing Funds Through a Single Combined Application — On March 30, 2016, the City Council's Committee on Budget approved Resolution 16-62 relating to the funding source for homeless assistance. Introduced by Councilmember Joey Manahan, the purpose for the resolution is to urge the City's administration to work with the State, and establish a collaborative funding process by which homeless service providers and developers may apply for funding. The current funding model is timely and inefficient and requires various applications to secure funding for programs targeting homeless. Councilmember Manahan proposes a new funding model be implemented that is structured similar to the State of Washington and combines the funder's application process.

## HART Awards Fare Systems Contract

The Honolulu Authority for Rapid Transportation, in a joint procurement with the City's Department of Transportation Services (DTS), has awarded to INIT Innovations in Transportation, Inc. of Virginia a \$31 million contract to design, build, operate and maintain a new smart card pass system for use on TheBus and the Honolulu rail transit system.

"The smart card pass system not only lays the groundwork for Honolulu's multi-modal transportation system, it also helps us better meet the needs of the transiting public." said city DTS Director Mike Formby.

"With the award of the fare systems contract, we're now on our way to providing our customers with the smart card technology they'll use to ride the rail transit system," said HART Executive Director and CEO Dan Grabauskas.

INIT will provide new smart card readers on TheBus and ticket vending machines and fare gates at the rail stations.

The contract also calls for customer service terminals at Satellite City Halls and retail outlets to sell passes and load value onto the cards.

The contract is for design plus ten years of operation.

## Registration opens for camping at Hickam Harbor

Joint Base Pearl Harbor-Hickam Morale, Welfare & Recreation (MWR) is once again presenting a weekend of camping, family activities and a movie under the stars April 22-23. The two-day event is being organized and managed by MWR's Outdoor Recreation (ODR) department.

The weekend begins with setting up camp on the grass at Hickam Harbor at 4 p.m. April 22. Attendees can spend the afternoon creating their own fun.

As the sun sets, ODR will set up a movie screen so everyone can view a family-friendly film under the stars. At the conclusion of the film, families will camp out for the night.

When the morning comes around on April 23, camping gear will be packed away to make room for the next event, the annual Earth Day Celebration. There will be live musical entertainment featuring the Navy's Pacific Fleet Band as well as food vendors, information booths, events and activities to entertain and educate kids and adults.

For those wishing to camp overnight, advanced registration is required. Reservations for the camp start April 1 and are being accepted at the Hickam Harbor Marina office. Cost is \$30-\$35 to reserve a camping space. The fee does not include camping gear. Those wishing to rent camping equipment can contact the Outdoor Adventure Center (OAC) at 473-1198 for information. Camping time is from 4 p.m. on April 22 to 8 a.m. on April 23.

The Earth Day celebration begins at 11 a.m. Attendance is free and is open to all base-eligible patrons. Patrons do not need to camp the night before to attend the Earth Day festivities.
